1. The diversion processing fee of **\$125.00** is Non-Refundable. You must pay with a personal check/cashier's check or money order (**NO CASH or CARD** accepted).
2. You must reside in Reno County for the entirety of the diversion period- diversion cannot be transferred to another county.
3. Once your application is received, it will then be up to the District Attorney whether or not you are approved for Diversion. Upon approval or denial, your attorney will be contacted by the District Attorney's Office. Please advise the Diversion Office of any changes in your phone number and/or address while awaiting approval/denial.
4. You must pay the \$120.00 Supervision Fee (check or money order) at the time of your diversion hearing that is scheduled with your attorney following your approval.
5. Estimated Fees: **(In addition to the \$125.00 application fee)**
 - Supervision fee - \$120
 - KBI lab Fees (If applicable) - \$400.00
 - Drug diversion monitoring fee - \$380.00
 - Random UA's - \$20.00 each
6. Upon approval and signing of your Diversion Agreement, you will be on "Diversion" for a period of approximately 18-months. During that time, you will be required to remain abstinent from Drugs **AND** Alcohol **OR** any other mind altering substances; Follow the Recommendations of your supervising officer; Submit to frequent and random UA's; Periodic check-ins with the Diversion Coordinator and/or your supervising officer and any other conditions as directed by the District Attorney, Diversion Coordinator or your supervising officer.
7. Violation of the agreement and/or terms could result in the revocation of your diversion and the case being referred back to District Court for a trial on stipulated facts.
